# **Volunteers Encouraged to Join Time Bank**

Volunteers are being encouraged to join the Basildon, Billericay & Wickford Time Bank to earn 'credits' for the time they spend helping others.

Timebanking is volunteering with a twist. It's a community-initiative which encourages local people to share some of their time and skills directly with others. For every hour spent volunteering, Time Bank members can earn one 'time credit' which they can then use to ask someone for an hour of their time.

If you have volunteers supporting your organisation, they can sign up and 'bank' the hours they volunteer with you as a group. Some of the hours earnt by volunteers can also be donated back to charities – so if you need a hand, perhaps a Time Bank member can help!

# **People's Postcode Trust - Community Project Small Grants**

Short-term, designated funding is available for projects which focus on the prevention of poverty, promotion of human rights, through combatting discrimination and employability and skills development in Great Britain.

Grants range from £500 to £20,000.

The Round 2 dates are as follows:

- Stage 1: 1 August 15 August 2018
- Stage 2: 5 September 19 September 2018.

The application form will appear online during the stage 1 dates.

The funding is for new projects, or significant expansions of existing projects, in Great Britain. The projects can be up to 12 months in length.

In 2018, the Trust will consider projects which focus on:

The programme has two funding rounds and an online two-stage application process involving an expression of interest form. Those who are successful at the initial stage will be invited to complete a full application. As this scheme is 'vastly oversubscribed', applicants are urged to read the guidance notes that can be found on the Trust's website before starting the application form.

# **Building Connections Fund**

The £11.5 million Building Connections Fund is a partnership between Government, Big Lottery Fund and the Co-op Foundation which was set up in response to the Jo Cox Commission on Loneliness to support projects that prevent or reduce loneliness.

#### The fund aims to:

- Increase social connections, helping people form strong and meaningful relationships and creating a sense of community and belonging, and helping people feel more connected
- Support organisations to build on their existing work, eg by reaching more people, or working in a new area or with a different method or group of people
- Encourage organisations to join up with others locally
- Improve the evidence base and use learning to inform longer term policy and funding decisions.

### The fund is split into two strands:

1. Main Fund: available for organisations with existing projects that are already helping to build connections to prevent or reduce loneliness, projects that could reach more people and / or join up with others and include ways of utilising existing expertise in the sector, increasing geographical reach and improving impact.

Grants are between £30,000 and £100,000. It is open for applications now.

2. Youth Fund: this will be distributed by the Co-op Foundation, making grants of up to £80,000. It will open for applications in August 2018 – find out more on the Co-op Foundation blog.

### The Postcode Dream Trust

Funded by the People's Postcode Lottery, the Postcode Dream Trust is offering to fund organisations dream projects.

### Projects must deliver on one of the following outcomes:

- Changing lives through early intervention
- Ending loneliness and social isolation
- Protecting britain's biodiversity
- Sustainable systems change
- Transforming society through sport

**Who can apply:** All applications must come from at least two not-for-profit organisations who have joined forces to deliver their 'dream' project. The lead partner must be a registered charity.

Maximum grant: £1 million

# **Work and Health Challenge Fund - Application Portal**

The Work and Health Unit (WHU), which is jointly managed by the Department for Work and Pensions and the Department of Health and Social Care, is using a £4.2m Challenge Fund to test new approaches that can help people experiencing mental health and/or musculoskeletal (MSK) issues stay in work.



They are looking to fund around twenty Initiatives which will improve their understanding of what works in one or more of the following areas:

- Helping people stay in work by increasing their ability to self-manage their conditions.
- Helping people access advice and support about what sort of work they might be capable of doing given their wider needs and circumstances.
- Developing new approaches to help employers and individuals develop workplace solutions, or ways of working that facilitate greater participation of people experiencing these conditions.
- Improving systems by joining up services to strengthen communication, liaison or joint action.

They welcome applications from employers, charities, social enterprises, local authorities, health bodies and others from across England, Scotland and Wales.

The deadline for receipt of Challenge Fund applications is Friday 17th August at 17.00. Projects are anticipated to run between October 2018 and February 2020.

# **2019 GSK IMPACT Awards - Core Funding and Free Training for Health Charities**

GSK's IMPACT Awards reward charities that are doing excellent work to improve people's health. Organisations must be at least three years old, working in a health-related field in the UK, with income between £80,000 and £2.5 million.

Up to **20 awards** will be made ranging from **£3,000** to **£40,000** plus free training valued at up to **£6,000**. Organisations will also have a film made, receive help with press and publicity and be given a set of promotional materials.

### The National FGM Centre



Developing excellence in response to FGM and other harmful practices The <u>National FGM Centre's</u> vision is to keep children and young people safe from <u>FGM</u> and other Harmful Practices, including <u>Breast Flattening</u> and <u>Child Abuse Linked to Faith or Belief.</u>

Through their work they aim to:

- Prevent new cases
- Protect children and young people
- Support those affected by FGM and other Harmful Practices
- Partner to deliver services and learn

They have had 280+ case referrals between Sept 2015 – April 2018 from our Local Authorities in the East of England and 14 from other Local Authorities in England and Wales. *Of these, 100+ have been from Essex.* They have also supported the application of 16 FGM Protection Orders over this time.

### How can the Centre help you in Essex?

Essex County Council has commissioned the National FGM Centre to work in the region covering the above topics. The National FGM Centre has a specialist worker, **Rohma Ullah**, who works across the county on all cases regarding FGM, Breast Flattening and Child Abuse Linked to Faith or Belief jointly with social workers. # **Children Affected By Domestic Abuse Fund**

<u>The Home office</u> have allocated £8 million of funding to fund interventions designed to support children affected by domestic abuse.

### Interventions should:

- Demonstrate evidence for proposed plans
- Provide arrangements for safeguarding vulnerable children and young people as part of the planned activities
- Show how proposed support will link into wider support for victims of domestic abuse at a local level

**Who can apply:** Local commissioners. This can include police and crime commissioners, local authorities, health commissioners, or any other suitable organisations across England and Wales.

Partnership applications are also welcome. For more information, read the fund prospectus.

**Maximum grant:** Discretionary

While there is not a formal cap placed on the amount an organisation can bid for, all bids must be scalable. **Organisations must bid for a minimum of £500,000.**

# Cabinet Reshuffle - Implications for the VCSE Sector

Did you notice the flurry of changes within the cabinet in some key positions which may well impact upon the voluntary sector.

Jeremy Wright replaces Matt Hancock as Secretary of State for Digital, Culture, Media and Sport (DCMS). The move to DCMS is a significant shift from his specialism. It's also notable that he has already been criticised for his lack of digital expertise (including not having a Twitter account). This marks him out as a polar opposite of his predecessor who is known for his enthusiasm for digital technology.

Jeremy Wright will have a key role to play in the implementation of the forthcoming Civil Society Strategy and potentially in digital skills and digital transformation across the charity sector.

Matt Hancock replaces Jeremy Hunt as Secretary of State for Health and Social Care. His predecessor secured agreement from Theresa May that the NHS would receive a £20bn real-terms funding boost by 2023. The recent NHS Provider's report outlines that the extra funding will only make up "lost ground" caused by years of austerity. Matt Hancock's key challenge will be to ensure that the new funding is distributed and invested as effectively as possible.

Moving over from DCMS where he also had responsibility for the charity sector we would hope that Matt recognises the amazing contribution that the voluntary sector makes and that they are a vital partner in Health and Social Care.

The voluntary sector plays a hugely important role in creating a stronger civil society and by connecting people to create powerful communities. We look forward to working with both figures to ensure that value of the VCSE sector is recognised and that it is supported through investment.



# Prepare For the Charity Annual Return 2018

Last year the Charity Commission consulted with the charity sector about the annual return for 2018. Based on the outcome of this consultation, the Commission is introducing a tailored annual return later this summer. It will include new questions that charities can start preparing for now.

For some charities the new questions will create additional work, so the Charity Commission has published information which may help in preparing for the return. You can <u>find this</u> information here

# **Communities Can Be Powerful – But They Need Support**

The new report, *The Future for Communities: Perspectives on power*, concludes an 18 month research project that asked 'what needs to happen for communities to feel and be more powerful in the future?' It paints a picture of strong, resourceful communities affected by the challenges of poverty, transience and isolation; but also people and places where resilience and hope offer the prospect of positive transformation and change. In particular, it highlights the need for sustained investment in supporting community-level infrastructure – places to meet, organisations to bring people together and people to



facilitate engagement. The research was commissioned by Local Trust, carried out by the Institute for Voluntary Action Research (IVAR), and funded by the Community Development Foundation (CDF) and the Joseph Rowntree Foundation (JRF).

### **Trust in Charities 2018**

This report, published by the Charity Commission for England and Wales, presents the findings of independent research conducted by Populus into public trust and confidence in charities in 2018. The main objectives of the report are to:

- investigate overall public trust and confidence in charities, comparison with other sectors and changes over time
- identify what the public consider to be trustworthy behaviours in charities
- explore whether trust influences support, for example in terms of donations.

#### After Carillion: Public sector outsourcing and contracting

This report, published by the House of Commons Public Administration and Constitutional Affairs Committee, asks 'How appropriate is it for public services or projects to be run by the public sector?', making conclusions and recommendations in light of the recent Carillion failure and acknowledging the damage done to public trust in outsourcing, and what the government must now do in approaching contracting and managing risk.



Hearing Help Essex, a registered not for profit charity assists people with acquired hearing loss. There are more than 11 million people in the UK with some degree of hearing loss and a quarter of a million people in Essex alone have some degree of hearing difficulty, which can come about for all sorts of reasons, making day-to-day communication far less easy.

Practical information, advice and guidance on how best to adjust to wearing NHS hearing aids and managing hearing loss will be made available. There will also be the opportunity to learn more about assistive equipment and the benefits of technology that can really help.
