CHIEF OFFICER'S REPORT

Welcome to the Spring Edition of our newsletter. I did check and apparently Spring

differs depending on whether you are using the meteorological or astronomical seasons.

In this edition we include our latest funding updates, volunteering news and the latest VCS diary.

Building a Shared Society

Nationally, the news continues to be dominated by Brexit, the Budget and now Scotland. You may therefore have missed the Prime Minister's welcome contribution to the debate to the role of voluntary and community organisation in the recent speech to the Charity Commission.



In the speech the Prime Minister stressed that working with charities, campaign groups and social enterprises is key to her agenda. As a result she has <u>dropped</u> the previous government's gagging clause – a tool that prevented charities in receipt of government grants from giving policy advice to government based on vulnerable people's experiences.

Whilst some will remain sceptical, for others it will be a relief that this Prime Minister has promised to be a "supporter" and "champion" of the sector at a time when it feels it has few friends.

Against this backdrop a recent survey of charity leaders reveal that one in five UK charities are 'struggling to survive'. Charity leaders are reported to be less confident this year about facing rising demand for services as the financial climate gets tougher.

"The research, shows that more than a third of charities had to dip into their reserves last year to cover a shortfall in income" Source The figure for smaller charities is more stark with more than a quarter "struggling to survive" in the face of growing demand and a tough financial climate.

The <u>survey of UK charity chief</u>
<u>executives</u> published on 28 February by the
Charities Aid Foundation (CAF), has revealed
that 18% of all UK charities fear for the future of
their organisation, rising to 28% of charities with
an annual income of less than £1m. The
research, shows that more than a third of
charities had to dip into their reserves last year

to cover a shortfall in income, with 34% of the charity leaders in the survey saying that reductions in public and government funding is their biggest challenge.

As a CVS we are committed to undertaking a state of the sector report to assess the local position, so watch out for this.

Charity Commission gets Treasury go-ahead to consult on charging charities

A letter to the Lords Select Committee on Charities from William Shawcross and Paula Sussex, Chair and Chief Executive of the regulator, says a Charity Commission

consultation on charities will be launched 'shortly'.

Whilst the scope of the consultation has yet to be published, early indications suggest that the Commission is looking at several possible mechanisms for charging charities for its services. This money will then be used to address its own funding shortfall as its funding has been roughly halved in real terms since 2008 to £20.3m a year.

How much might we charge?

Annual Levy, example options:

Fixed fee, all reg'd charities: £140

Fixed fee, reg'd charities over £10K: £265

Fixed fee, reg'd charities over £10K: £265

Sliding scale fee by income, all reg'd charities: £50 - £1,250

Sliding scale fee by income, reg'd charities over £10K: £140 - £1,500

Each of these options would generate around £23m p.a.

Ideas previously mooted included a

fixed annual fee of £140 for all registered charities and a sliding scale that would involve the largest charities paying £1,500 a year.

Unsurprisingly perhaps, charities have previously expressed overwhelmingly opposition to the plans.

Budget 2017 and the VCSE Sector

The final element of national policy round up relates to the Budget 2017. Chancellor of the Exchequer Philip Hammond has delivered the final Spring Budget before it moves to an autumn event later this year.

As expected, the Chancellor offered little in the way of direct support for the sector, making no specific references to charities, social enterprises or the sector in general during his speech.

However, a number of commitments were made including £20 million to be made available to tackle domestic violence and abuse against women and girls; and a range of women's charities across the UK will collectively benefit from £12 million as previously announced in the Autumn Statement. The list of charities will be published before the end of March 2017.

The Chancellor also announced £5 million for projects to celebrate the Representation of the People Act 1918 - the centenary of women first getting the vote - and to educate young people about its significance.

While an extra £2 billion was announced for adult social care over the next three years, this figure is less than the £1.5 billion the cross-party Communities and Local Government Committee found was needed this year alone.

Charities may potentially benefit from the £300 million fund to provide discretionary relief on business rates.

Arts and Heritage funding

For the past five months Nesta has been running a <u>pilot</u> <u>programme</u> to see if matched crowdfunding - that is funding bodies combining grant funding with multiple financial contributions from the crowd - can stimulate exciting and dynamic new projects in the arts and heritage sectors.



The match funding available is now 50 per cent of the campaign total for applicants to the fund on projects aiming to raise between £4,000 and £40,000.

Therefore, between £2,000 and £20,000 is available per project, depending on their crowdfunding target.

Funding is available on condition that projects hit their originally stated target.

The funding is now available to all donations and rewards based projects that meet the basic eligibility requirements on Crowdfunder.

Sport England Offers Funding for Volunteering Through Sport

Sport England has launched two new one-off funds to support Sport England's new strategy (Volunteering in an Active Nation) which aims to get more people engaged in all types of volunteering through sport and physical activity.

Organisations can apply to the following:

- The Opportunity Fund aims to get people aged 20 years and older from
 economically disadvantaged communities to volunteer. The funding is for projects
 that benefit people facing disadvantage as a result of the community they live in –
 and that allow them to make a positive contribution to those communities. Projects
 could range from inner-city areas with high levels of crime and social exclusion to
 remote rural areas with few services.
- The Potentials Fund aims to create more opportunities that get people helping others from an early age. Projects should target children and young people between the ages of 10 and 20 years (particularly those between the ages of 10 to 14 years) who are interested in doing something to benefit their community through social action. Sport England is 'keen to test bold new approaches' to get young people involved in social action that includes sport and physical activity, especially those who haven't been involved in sport previously.

Both funds offer grants of between £50,000 and £150,000 which are available over three years. There is a two stage application process. The application deadline for expressions of interest (stage one applications) is 24 April 2017 (12 noon).

Greggs Foundation Launches Round 2 of its Local Community Projects Fund

The Greggs Foundation uses the money raised from the 5p levy on carrier bag sales in Greggs shops to provide grants to small not-for-profit organisations for projects that make a difference to local areas. Although any size organisation can apply, the Foundation is more likely to fund those with an income of £300,000 or less.

Grants of up to £2,000 are available for projects and providing equipment for people in need at the heart of local communities. Eligible organisations should be working with those who are:

- Disabled or suffering chronic illness.
- Living in poverty.
- Voluntary carers.
- · Homeless.
- Isolated older people.
- In significant, demonstrable need.

Eligible projects should be able to show that they meet at least one of the following Key Performance Targets for their beneficiaries:

Decreased social isolation.

- Improved health and wellbeing.
- Improved resilience/coping mechanisms.
- Improved life skills.
- Improved opportunities.

Projects should improve resilience within a community of interest and can include sessional activities/respite support, equipment for sessional activities, trips and residential breaks. The Foundation is also interested in new approaches and innovative ideas as well as sustainable approaches to supporting the community of interest.



There are two funding rounds per year. The deadline for round two applications is 24 June 2017. Groups will be notified if the Foundation is unable to accept applications.

UnLtd awards

The Do It Awards from UnLtd provide support and funding packages for individuals to run projects that have a positive social impact and have the scope to become financially sustainable.

To apply you must be an individuals aged 16 or over, live in the UK, are not part of an established organisation seeking funding for projects that:

- Have a real social impact
- Fulfil a clear need and demand
- Have clear outputs and goals
- Provide a learning experience or opportunity.



The maximum grant is discretionary.

Deadline: 27 March and 3 August 2017.

Services for Unpaid Family Carers in Essex (not Southend and Thurrock)

ECC is currently recommissioning services to support unpaid family carers in Essex (over the age of 18yrs) with a view to having a new service/s in place by 1st April 2018.

They will be undertaking a tender process to secure these services later in the year however, we wanted to make you aware that they will be hosting a market engagement event on

5th April 2017, 10am to 12noon in Chelmsford to test the potential model with providers.

The Veolia Environmental Trust

The Veolia Environmental Trust provides grant funding to community and environmental projects in England and Wales through the Landfill Communities Fund, using money provided by Veolia. In the 20 years since it was established, the Trust has awarded more than £68 million to more than 3,000 projects.

The Trust will consider applications from constituted not-for-profit organisations with a bank account that have a project that addresses at least one of the following categories:

- Community buildings and rooms, including community centres, village halls, community spaces within religious buildings, and Scout or Girlguiding buildings.
- Outdoor Spaces, including public parks, nature reserves, community gardens, footpaths, bridleways and cycle-paths.
- Play and recreation, including play areas, skateparks, Multi Use Games Areas (MUGAs), sports grounds, pavilions and changing rooms.
- Supporting Biodiversity, including the species related element of a BAP (national or local), the habitat related element of a BAP or HAP (national or local), and reintroduction programmes to a specific habitat.

The funding is to be used for capital improvement projects taking place at a single site.

Grants of up to £75,000 are available to cover 80% of a project's total cost. Match funding of at least 20% is required. Groups requesting grants of £40,000 or more are required to provide a Third Party Contribution.

The next deadline for stage one applications is 25 May 2017 (noon).

VOLUNTEERING

A NEW ANALYSIS OF VOLUNTEER BEHAVIOUR

Whilst on the theme of volunteering, you may be aware that the Office for National Statistics has the recently released its latest volunteering data. A useful analysis of the latest headline data has been provided by the NCVO in a blog by Nick Ockenden, Head of research at NCVO. (16 March 2017)

It concludes that overall rates of volunteering are still high, steady and that volunteering is "resilient". He suggests that "we should recognise that volunteering is a core part of our society that's embedded in many, many people's everyday behaviour". The blog identifies a number of other issues including young people giving more.

Volunteers giving less time

Potentially one of the most interesting findings was that volunteers are spending less time volunteering, drawing data from the <u>Time Use survey</u>. It suggests that we "would do well to turn more of our attention to how we can best support, manage and retain existing volunteers, alongside recruiting new ones".

Young people are doing more

Nick has previousl blogged about <u>recent increases in volunteering by younger people</u> <u>last year</u> (a rise which has since levelled off). The new data adds more to this trend.

The analysis found that just over half of those aged 16-24 volunteered for an average of 17 minutes a day, the highest of all age groups in terms of both average the time spent volunteering and overall rates of engagement. But it also managed to pull out some interesting things about the behaviour of students, who were more likely to volunteer and would spend more time volunteering than people in paid work. He concludes that it does show a highly-engaged group of young people and suggests an important role for schools, colleges and universities in facilitating volunteering.

What should volunteer-involving organisations do now?

The analysis helpfully concludes with a number of idaeas for what we can do now.

Firstly, take a look at the opportunities you offer volunteers and ask yourself how flexible they really are.

Secondly, explore some of the good practice about how to involve volunteers in new ways (<u>family volunteering in the National Trust</u> and micro-volunteering spring to mind) and ask whether you could do anything similar.

And thirdly, kick off a debate about volunteer management within your organisation. To what extent are you geared up to respond to the changing way in which people are volunteering, particularly if these trends continue?

CONSULTATION

Public Health and the Voluntary Sector

The Local Government Association (LGA) has published a <u>report</u> in conjunction with Volunteering Matters highlighting where public health is successfully working with the voluntary sector across the country.

Catchily entitled "Public health working with the voluntary, community and social enterprise sector: new opportunities and sustainable change" champions the need for supporting local voluntary sector infrastructure, stating they are "central to the VCSE relationship with



public health" and contribute "massively to an extended role in service delivery".

It also includes good examples of how NAVCA members - such as Sefton CVS, Tower Hamlets CVS and Nova Wakefield - have enabled the voice of the local communities and voluntary groups to be heard at a strategic level.

CONSULTATION

Have you recently visited A&E in Basildon, Chelmsford or Southend?

<u>HWE Insights</u> is conducting a research project which focuses on urgent and emergency care in Essex. The research aims to identify and understand what factors influence a person to visit A&E, and seeks to examine people's views on the proposed changes.

The <u>Essex Success Regime</u> has plans to change how urgent care services are delivered across the three hospitals (Basildon, Broomfield and Southend). The findings from this study will feed into the formal consultation process, helping to shape how the proposed changes will be implemented.

We're looking for people who have used A&E services in the last 2 months to take part in group discussions. During the group discussions participants will be asked questions about their experiences and opinions of urgent and emergency care, and the affects of the proposed changes. We expect the group meeting to last approximately 4 hours, including breaks and refreshments. We will randomly select participants so you may or may not be contacted to take part. Each participant will receive a £40 voucher in appreciation of their time and to cover any travel expenses. These meetings will take place at:

- 1. Basildon, Saturday 1st April, 10am 1pm, Location TBC
- 2. Chelmsford, Tuesday 4th April, 5pm 8pm, Location TBC
- 3. Southend, Saturday 8th April, 10am 1pm, Location TBC

To take part in this study, you should live in Essex, be over 18, and have visited Basildon, Broomfield or Southend hospital A&E in the last 2 months. To register your interest in taking part please complete the form below:
