The Garfield Weston Foundation



£5m fund launched to support local charities. The Garfield Weston Foundation has launched a new £5m fund to celebrate its 60th anniversary year, with a view to help local charities provide new or improve existing community facilities.

Up to £150,000 is available to projects that successfully apply. The Foundation is using this anniversary year to acknowledge the vulnerable position that many small and local charities are in, and by offering capital funding it hopes to invest in much needed facilities that will enable them to continue providing support.

Fundraising and Direct Marketing

Basic and detailed resources:

- "Marketing, marketing", a very short summary of when you do and do
 not need consent for fundraising and direct marketing, and what to do now if you

- The Information Commissioner's Office's FAQs for charities can be found here, in particular the FAQs on consent which make clear that consent is not needed for postal fundraising/marketing, but is needed for some calls and for texts and emails not only under GDPR but also the Privacy and Electronic Communication Regulations 2003 see the ICO's guide to PECR here. The ICO says in its charity FAQs, "if you don't need consent under PECR you can rely on legitimate interests for marketing activities if you can show how you use people's data is proportionate, has a minimal privacy impact, and people would not be surprised or likely to object".
- GDPR: The essentials for fundraising organisations, covering getting to grips with the basics; 'opt in' consents vs 'opt out'; and FAQs. Published May 2017, 19pp, free download here. For more GDPR resources please visit here.

- Post-GDPR changes to the Code of Fundraising Practice to the Code page on the Fundraising Regulator's website. Follow this <u>link</u>, and click on Post-GDPR changes on the left-hand side.
- News release summarising the post-GDPR changes can be viewed here.
- Fundraising Regulator's guidance to be published in the next couple of weeks, produced in partnership with the Information Commissioner's Office, Institute of Fundraising, Charity Commission National Council for Voluntary Organisations, Wales Council for Voluntary Action and Northern Ireland Council for Voluntary Action. The guidance will be the main source of information for any organisation that uses personal data for fundraising or direct marketing.

Changes to the Children in Need Small Grants Programme

Children in need fund projects that support children and young people of 18 years and under, who experience disadvantage through:



- 1. Illness, distress, abuse or neglect
- 2. Any kind of disability
- 3. Behavioural or psychological difficulties
- 4. Living in poverty or situations of deprivation

A number of changes have been made to the way the small grants programme is delivered. These include a change in funding levels, changes to the application form, a new eligibility checklist and more.
